



## **COVERAGE**

CorrTableSports, L.L.C. (“CTS”) warrants to the original end user (“Customer”) that this product will be free from defects in material and workmanship, under normal use, for a period of ninety (90) days from the original purchase date.

## **EXCLUSIVE REMEDY**

Should a covered defect occur during the warranty period and Customer appropriately notifies CTS, the sole and exclusive remedy, at the option and expense of CTS, shall be to provide Customer with new or refurbished replacement parts or product. Any labor required will be at the sole expense of Customer. At its sole discretion, CTS may request Customer to send or return the defective parts or product, at the Customer’s shipping expense, to CTS at an address to be provided. Repair and replacement parts or products will be shipped to Customer at CTS’s expense. All products or parts that are replaced become the property of CTS.

## **EXCLUSIONS**
